Dear Shareholder,

We are writing to inform you of changes, made to the prospectus of the T. Rowe Price Funds SICAV (the "Company") in the September 2021 update, which affect the following funds:

- Asian ex-Japan Equity Fund
- US Aggregate Bond Fund

With effect from 2 November 2021, the abovementioned funds will be changed as follows:

- Although the funds will not have sustainable investment as an objective, the promotion of environmental and social characteristics will be achieved through the investment manager's avoidance of sectors or companies, whose activities may be considered harmful to the environment and/or society through the application of its proprietary socially responsible screen (exclusion list). As a consequence, specific companies whose business activities involve controversial weapons (cluster munitions, anti-personnel mines, incendiary, chemical, biological and nuclear weapons), tobacco production, coal production, assault-style weapons for civilian use, adult entertainment, direct gambling operations and certain conduct-based criteria will be excluded. For further details see the T. Rowe Price Responsible Exclusion List section in the prospectus.
- Any use of derivatives will aim to be consistent with the fund's objectives and the
 environmental and social characteristics described within the 'Objective and Investment
 Policy' of the fund.
- Through the application of the T. Rowe Price Responsible Exclusion List, the funds will aim
 to reduce the harmful impact on the environment and/or society of controversial weapons,
 smoking/tobacco, adult entertainment, direct gambling operations, coal production and
 conduct based exclusions. Sustainability indicators will be used to monitor and assess the
 extent to which a fund attains the environmental and social characteristics that it promotes.
- The funds will be categorised as Article 8 under Sustainable Finance Disclosure Regulation (SFDR).
- The benchmark of each fund will a broad market index and, as such, not aligned with the environmental and social characteristics of the fund.
- As a result of the above changes, the names of the funds will change, as follows:
