Franklin Templeton Investment Funds子基金之投資政策修訂

股東鈞鑑:

本信件旨在通知您·富蘭克林坦伯頓基金集團(以下稱「本公司」)董事會已決定對富蘭克林坦伯頓全球投資系列-天然資源基金(以下稱「本基金」)之投資政策進行修訂·以引入對私人企業、上市後私募投資(PIPE)和特殊目的收購 公司(SPAC)所發行之證券的投資。因此,以下詞語新增至本基金投資政策的結尾處,自2022年6月26日起生

「根據投資限制,本基金最多還可(i)將其淨資產的10%投資於私人公司和上市後私募投資(PIPE)所發行的證券, 以及(ii)最多可將其淨資產的5%投資於特殊目的收購公司(SPAC)·惟根據2010年12月17日之法律第41條第(1)或 (2)a)款,擬設立之PIPE及SPAC符合可轉讓證券之條件。」

此外,新增「股票風險」、「PIPE風險」、「私人企業風險」及「SPAC風險」納入本基金的風險考量部分。

本次異動將不會對本基金的管理方式、其投資組合的組成、風險或流動性概況或收取的費用產生實質性影響。新投 資政策將反映在本企業的更新版公開說明書中・您將可在線上或在企業註冊辦事處獲得其副本・本基金的所有其他 特徵保持不變。

您需要做什麼

如果您對變更感到滿意,無需執行任何操作。只要該等基金可於您所在的國家/地區分配,您亦可選擇將您的股票轉換為 公司的其他基金或是要求贖回您的投資。無論您欲採取任一選項,請參閱最新的公開說明書條款。本公司將免費處 理2022年6月26日前收到的此類轉換或贖回要求。

Amendment to the investment policies of two sub-funds of Franklin Templeton Investment Funds

Dear Shareholder,

We would like to inform you that the board of directors of Franklin Templeton Investment Funds (the "Company") has decided to amend the investment policies of the Franklin Gold and Precious Metals Fund and Franklin Natural Resources Fund (the "Funds") to introduce investments in securities issued by private companies, Private Investments in Public Equity (PIPEs) and special purpose acquisition companies (SPACs). Therefore, with effect from June 26, 2022, the following sentence is added at the end of the Funds' investment policies:

"The Fund may also, in accordance with the investment restrictions, invest (i) up to 10% of its net assets in securities issued by private companies and Private Investments in Public Equity (PIPEs) and (ii) up to 5% of its net assets in special purpose acquisition companies (SPACs) provided that the contemplated PIPEs and SPACs qualify as transferable securities under paragraphs (1) or (2) a) of Article 41of the Law of 17 December 2010."

In addition, new "Equity risk", "PIPEs risk", "Private Companies risk" and "SPACs risk" are added to the risk considerations of the Funds.

There will be no material impact on the way the Funds are managed, their portfolio's composition, risk or liquidity profile, nor on the fees charged. The new investment policies will be reflected in an updated version of the prospectus of the Company, a copy of which will be available online or at the registered office of the Company, upon request. All other features of the Funds remain the same.

What you need to do

You do not need to do anything if you are satisfied with the change. You also have the option to switch your shares into other funds of the Company provided that such funds are available for distribution in your country. You may also request a redemption of your investment. Should you wish to proceed with either option, please refer to the latest prospectus terms. Such requests of switch or redemption will be executed free of charge, provided that they are received at the latest by June 26, 2022.
