我們謹此通知您,自 2024 年 3 月 28 日起生效,富蘭克林坦伯頓全球投資系列 - 多空策略基金(以下稱「本基金」)的環境及或社會特徵附件(SFDR annex)進行一些內文調整,以便 (i) 排除兩項主要不利影響(溫室氣體排放及溫室氣體強度), (ii) 修改「此金融產品遵循什麼投資策略 ? 」段落的文字敘述(明確本基金對準(i)超過5%的收入來自煙草生產或分銷的公司及(ii) 超過30%的收入來自煤炭生產或分銷的公司之長期曝險合計為0%)以及 (iii) 更新其中一項投資策略之約束要素(闡明如下:「以投資組合的相關證券長期曝險為基礎,承諾須達加權平均 ESG評分高於 i) 投資範疇的MSCI ESG評分之中位數;或 ii) MSCI ESG評分5.25,以較高者為準。如果本基金的得分低於此門檻,投資經理公司將重新平衡投資組合,以期在90天內達到 5.25 或更高的基金得分。」)。



ESG updates of Franklin K2 Alternative Strategies Fund

Dear Shareholder,

We would like to let you know that effective 28 March 2024, some adjustments were made to the SFDR annex of the Franklin K2 Alternative Strategies Fund (the 'Fund') in order to (i) remove 2 Principal Adverse Impacts (greenhouse gas emissions and greenhouse gas intensity), (ii) amend the wording under section "What investment strategy does this financial product follow" (to precise that the Fund targets 0% long exposure in aggregate to (i) companies which generate more than 5% of their revenues from tobacco production or distribution and (ii) companies which generate more than 30% of their revenues from coal production or distribution) and (iii) update one of the binding elements of the investment strategy (to clarify it as follows: "the commitment to reach a weighted average ESG score greater than i) the median MSCI ESG score of the investment universe; or ii) an MSCI ESG score of 5.25, whichever is higher, based on the long exposure in the portfolio of rated securities. If the Fund's score falls below this threshold, the Investment Manager rebalances across the Investment Co-Manager's sleeves within 90 days").

These enhancements are reflected in an updated version of the Prospectus of Franklin Templeton Investment Funds, a copy of which is available online or at the registered office of the company, upon request. All other features of the Fund remain the same and there will be no impact on the asset allocation, risk profile or on the fees charged to the Fund.

ESG updates of Templeton Global Climate Change Fund

Dear Shareholder,

We would like to let you know that effective 28 March 2024, the following updates were made to the SFDR annex of the Templeton Global Climate Change Fund (the '**Fund**'):

- update of the binding commitment to include reduction of the investment universe by at least 20%, by excluding companies with the worst climate scores according to the Investment Manager's proprietary methodology,
- update of the investment strategy section, including the removal of the resilient companies,
- removal of the NZAMI wording, and
- clarification of the minimum share of sustainable investments with an environmental objective that are not aligned with the EU Taxonomy if the Fund's share of sustainable investments with an environmental objective aligned with the EU Taxonomy exceeds its minimum commitment.

These enhancements are reflected in an updated version of the Prospectus of Franklin Templeton Investment Funds, a copy of which is available online or at the registered office of the company, upon request. All other features of the Fund remain the same and there will be no impact on the asset allocation, risk profile or on the fees charged to the Fund.
