We refer to the letter dated March 11, 2024 (the "**Letter**") and the Form of Proxy attached thereto (together referred to as the "**Documents**") that you received in connection with the Annual General Meeting of Shareholders of Franklin Templeton Shariah Funds (the "**Company**").

The Documents incorrectly stated the date and time of the Annual General Meeting of Shareholders as March 29, 2024 at 2.30 p.m. (Luxembourg time) when it should have stated March 28, 2024 at 3:30 p.m. (Luxembourg time).
