We are writing to you in your capacity as a unitholder in the Fund, to inform you of the result of the Extraordinary General Meeting (“**EGM**”) of the Fund, held at 33 Sir John Rogerson’s Quay, Dublin 2, Ireland at 10:30am (Irish time) on 16 July 2026 to consider and, if thought fit, to pass a special resolution in relation to the proposal for the Fund to merge into BNP Paribas Funds Asia Ex-Japan Equity, a sub-fund of BNP Paribas Funds. You do not need to take any action, however, we recommend that you read this letter.

The Manager wishes to inform Unitholders that the resolution was not passed by at least 75% of Unitholders present or represented by proxy votes in the Fund and the proposed merger will, therefore, not proceed.
